However, we need your voice to ensure the final policy provides robust, comprehensive protection for these invaluable ecosystems.

Mature and old-growth forests are not just essential; they are irreplaceable pillars of climate stability, clean water, and biodiversity. These ancient woodlands store billions of metric tons of carbon, safeguard countless wildlife habitats, and serve as natural buffers against soil erosion and flooding. As our planet grapples with the escalating impacts of climate change, preserving these forests has become more than critical—it's imperative for our collective future."

The New York State legislature ended its regular session in early June. The bad news is, they did not pass the Bigger Better Bottle bill or the Packaging Reduction bill. Environmental advocacy organizations leading the efforts will continue to ask for our support in the coming session, or in a special session if the Governor calls one before the end of this year.
